Content Design and Production:  
Operation Parent develops and presents in-house presentations, webinars and videos for the purpose of providing information to parents, guardians, coalitions and other organizations. Fees incurred on behalf of the development of this content include, but are not limited to: professional graphic design fees, videographer, website fees and web-hosting fees.

During 2019, we released seven "21st Century Prevention" videos which received over 12,000 views across various platforms of the internet (YouTube, Facebook, Vimeo, and the Operation Parent website).

During 2019, we held 10 webinars which received 5,000 registrants and 2,200 live attendees.

Handbook Cost of Goods Sold:  
We consider Handbook COGS as a program expense given the nature of the handbooks. Selling and distribution of handbooks directly aligns with the organization mission as it is communicating Operation Parent's information in a tangible manner. As a result of producing the hard copy handbooks, we incur printing and shipping fees.

Since 2015, we have delivered over 100,000 handbooks to parents, school districts, local governments, churches, coalitions, and other organizations. These customers were located in 37 states.
